





WHEREAS the Settlers have created a trust by contributing Rs.10,000/- (Rupees Ten Thousand only) each and thereby delivered and made over to the trustees a total sum of Rs.90,000/- (Ruppes Ninty thousand) with intent to part with all their right, title and interest and vest the same therein to the trustees to have and hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represent the trust estate together with all additions and accretions thereto and all other accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise, may hereinafter be subject to the trust (hereinafter referred as the **TRUST FUND**) for the objects and purpose and uses hereinafter expressed with the powers and the terms and conditions herein contained of and concerning the same and the trust deed evidencing the creation of the trust was duly registered in the Sub Registrar office vide document no.187 dated 20-11-2008.

WHEREAS in the trust deed referred to above the name of the authors/settlers were left out inadvertently and certain clauses, which were compulsorily required for the purpose of claiming the exemptions under the "INCOME TAX ACT, 1961", were left out inadvertently.

WHEREAS the trustees have unanimously resolved to appoint Sri K.E.KANTHESH S/o K.S.Eshwarappa, aged about 29 years residing at "Jayalakshmi", Malleshwaranagar, Shimoga as Trustee and also as 'Treasurer' of the trust

AND WHEREAS the trustees felt the necessity of executing a fresh deed, incorporating the above mentioned inadvertent omissions, retaining the objects and other conditions mentioned in the trust deed registered vide document no.187 dated 20-11-2008 intact.

**NOW, THIS INDENTURE WITNESSETH AS FOLLOWS:**

(1) The name of the trust shall continue to be "PRAJNA EDUCATION TRUST" and the office of the trust shall continue to be at No.9, Kenchappa Complex, Durgigudi Main Road, Shimoga, which may be shifted from time to time to such other place or places as the trustees may deem fit and proper at their discretion.








(2) The objects of the Trust shall be:

- (i) To establish, promote, setup, run, maintain, assist/ or aid to or help in setting up and / or maintaining and / or running schools colleges and other institutions in the name of PRAJNA ACADEMY FOR CARRIER EXCELLANCE, which includes lower, higher education, basic, technical, non technical, medical, paramedical institution, research institutions, traditional schools of Gurukula-Patashala, Training Schools, and all other allied activities which are either incidental or necessary thereto for the advancement of education and or knowledge, of arts, science, literature, humanities and all other useful subjects in all their manifestations;
- (ii) To open, found, establish, promote, setup, run, maintain, assist, finance or support libraries, reading rooms, gymnasiums, hostels ad other training and vocational institutions;
- (iii) Encourage education and training in handicrafts, fine arts, Sports Clubs, youth services, seminars, camps, etc.,
- (iv) To grant to pay or give scholarship, stipends, prizes, rewards, allowances, and other financial assistances or help in cash or kind to students with a view to help them in promoting their studies in teaching, commercial and other arts including teaching of cultural arts and other training research or educational works in India or abroad and further to take affiliation to any other education institutions.
- (v) To publish books, pamphlets, periodicals and news papers in India or abroad for spread and advancement of education and culture.

(3) That, the financial year of the trust shall end on 31<sup>st</sup> March of every year, provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper. The first financial year of the Trust shall close on 31<sup>st</sup> March 2010. A Chartered Accountant appointed by the trustees for the purpose shall audit the accounts of the trust annually

(4) The trustees shall be the BOARD OF DIRECTORS to manage and administer the trust. There shall be a CHAIRMAN of the Trust who is one among the trustees. The minimum tenure of the Chairmanship shall be for three year, unless he is retired or expelled by the majority of trustees on charge of some serious

misconduct against to the interest of the Trust or otherwise cease to be Trustee. There shall be one Managing trustee to administer the day- to-day affairs of the Trust. The powers and duties of the Managing Trustee other than those mentioned in these presents shall be decided by the majority decision of the Trustee from time to time.

**(5) Powers, Functions and Privileges of Trustees:**

The Trustees shall manage and administer the trust. Without affecting the generality of powers and functions of the Trustees, they shall have the following functions:

- (i) That the trustees shall carryout the objects of the trust mentioned in Para 3 in spirit and letter and in accordance with the prevailing procedures, rules, regulations and statutes of the state.
- (ii) All trustees unless they voluntarily resign or otherwise decide, shall continue to be trustees during term of their natural lives.
- (iii) The number of trustees at any time shall not be less than two and not more than fifteen for the time being, but this maximum number may be increased subject to the majority decision of the prevailing trustees held in the meeting for this purpose.
- (iv) Any trustee may retire at any time without assigning any reason and without responsible for any costs occasioned by such retirement.
- (v) The surviving or continuing trustee may not notwithstanding any vacancy in the Board act as Trustees provided, however that if the number of trustee shall follow below, two the minimum fixed by these presents, the trustees shall not except for the purpose of filing any vacancy, act so long as the number is below the said minimum.
- (vi) In case of death or retirement of any trustee, his nominee shall be inducted in place of the deceased or retired trustee, if no nomination is found any one of his legal heirs to the majority decision of the continuing trustees shall fill the vacancy.
- (vii) One half number of surviving trustees at a meeting shall form the quorum for any meeting of the trustees.
- (viii) All proceedings and questions and matters arising at the meeting of the trustees shall be decided the majority of votes and in case of equality of votes,

the Chairman shall have a casting vote, provided however that, notwithstanding anything herein stated no question dealing with the disposal of the trust or investment out of trust property shall be decided except with the consent of the chairman and majority of the trustees.

- (ix) All meetings of the trust shall be held at such place and such time, as the Chairman/Managing Trustee of the trust shall decide from time to time. The Chairman shall preside over the meeting and in his absence one among the trustees present will act as the chairman for that particular meeting. The Managing Trustee shall call the meeting by circulating a written notice at least 24 hour before the intended time of the meeting.
- (x) A trustee who is unable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his 'vote' on the matter concerned.
- (xi) A resolution in writing circulated among all the trustees and signed by majority of trustees shall be as valid and effectuate as if it had been passed at the meeting of the trustees duly called and convened.
- (xii) Notice of the meeting of the trustees and all communications may be generally sent to the trustees at their addresses registered for the time being in the record of trust and for any other reasons may also be sent to their last known address for changed address.
- (xiii) The minutes of proceedings of every meeting of the trustees shall be entered in a book to be kept for that purpose and signed by the Chairman /Managing trustee of such meeting or the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.
- (xiv) The trustees may time to time frame schemes, rules regulations to carryout the object of the trust and for managing the affairs of the trust and may vary the same from time to time as they deem fit and proper.
- (xv) The trustees may reimburse themselves and pay and discharge out of trust fund, all expenses incurred by them in or about the execution of the trust or any of their duties by these presents including traveling expenses, but will not be entitled to any remunerations or profits.

experts in the respective fields as governing council or as members of advisory board for the effective function of the trust.

(xxiv) The trustees shall have powers to spend away portion of the property or income of the trust fund for purchasing of land, constructing any building and for any other purpose to achieve the objects of the trust.

(xxv) The trustees shall have liberty to sell such portion of the trust property movable or immovable either by public auction or by private contracts to the best of their discretion for such price in furtherance of the object of the trust and to execute all conveyance receipts for all moneys received by them.

(xxvi) The trustees may invest the trust fund or estate either in immovable properties or on any other property in the manner as allowed by law in the interest of the trust.

(xxvii) The trustees shall keep an account with any bank or banks, to operate such account or accounts whether in debit or credit and to give all appropriate instructions to the banker or bankers concerning the operation of such accounts and to authorise by appropriate resolution two or more of trustees jointly with an agent appointed by the board of trustees in this behalf to operate such account or accounts.

(xxviii) The trustees may pay all payables including duties, taxes, salaries and other incidental expenses, which are necessarily, required to carryout the functions of the trust. Trustees are not answerable for any loss occasioned their by in dealing with trust activities unless anything contrary is done with oblique or dishonest intention.

(xxix) The trustees may accept the donations, contributions in cash or kinds from any persons including non-resident Indians, firm, company, corporation, association, institutions, government bodies, authorities or organizations for the furtherance of the object of the trust. The Trustees may also taken over management of any other institutions of similar kind under such terms as they deem fit.

(xxx) The trustees may also accept Government grant/grants, aids and any other grant, or aid in cash or kind from any agency either within or outside India subject to the procedures and provisions of law.

(xxxi) The trustees shall cause true and accurate accounts to be kept in all moneys received and spent and all matters in respect thereof in course of

management of trust properties or in relation to the carrying out of trust objects as well as assets, credits and effects of the trust properties.

(xxxii) The trustees shall have full powers to compromise for compound all actions, suits and other proceeding and settle difference and disputes, touching the trust and its estate and properties and to do all such acts without being liable or answerable for any bonfire loss accessioned thereby.

(xxxiii) No person being (a) an un-discharged insolvent; (b) convicted of an offence involving moral turpitude or (c) of unsound mind or (d) a minor shall be eligible to be a trustee.

#### (6) AMENDMENT CLAUSE:

- No amendment of the Trust rules and regulations, bye-laws shall be made which may prove to be repugnant to the provisions of sections 2(15), 11, 12, 13 and 80G of the Income Tax Act, 1961.
- No Amendment shall be carried out without the prior approval of the concerned Commissioner of Income Tax.
- All Amendment approved by Trustees and Income Tax Department shall be registered with Sub-Registrar under Indian Trust Act and as per Indian Stamp Act.

#### (7) APPLICATION OF INCOME AND PROPERTY:

The Trust shall apply its income and property solely towards promotion of the objects of the Trust. No part of the income or property of the Trust shall be paid, spent or distributed or transferred directly or indirectly by way of dividend, loan or otherwise howsoever to any of the Trustees.

(8) For all purposes this trust deed shall replace the trust deed executed and registered vide document no.187 dated 20-11-2008 in the Sub-Registrar office, Shimoga.
